Welcome Note

Even though Jordan and Palestine are largely digitally connected, their populations remain significantly underbanked. Economic growth and financial inclusion are high on the priority list of both countries. Fintech solutions will thus be instrumental in closing some of these gaps and providing innovative solutions.

This year, we partnered with GIZ, FMO (the Dutch Entrepreneurial Development Bank), the SANAD Entrepreneurship Academy (European Union), and Zain Innovation Campus (ZINC), to identify 16 Jordanian & Palestinian fintech startups to participate in a 3-month training program that included 1:1 mentoring by regional and global experts, workshops, pitches to leading regional Venture Capitalists, access to funding, and much more.

For the Demo Day, we worked closely with our partners to arrange for 20+ Palestinian entrepreneurs from the West Bank and Gaza to travel to Jordan and pitch live before the investment community. They were joined by a similar number of Jordanian entrepreneurs. We are very proud of this achievement, especially in light of the challenging conditions many of these entrepreneurs have to face on a daily basis, and with the understanding that innovation through entrepreneurship and youth empowerment are the cornerstones of healthy economic development. We aim to provide these entrepreneurs with the tools and support they need to succeed against all odds.

We hope you too will support these budding entrepreneurs by funding them, partnering with them, and lending a helping hand in any way possible.





We kicked off the program with a virtual event on November 10th, 2022, with the attendance of our partners, the Changelabs team and all the admitted founders.




